MOTION FOR PRELIMINARY INJUNCTION/TEMPORARY RESTRAINING
ORDER, TRO 28 U.S.C. 1331

COMES NOW, the Plaintiffs, Jodi Arias and Christopher Alexander in Pro Se, facing imminent danger and bodily harm, moves this Honorable Court to issue a Preliminary Injunction and Temporary Restraining Order (TRO) against Nancy Grace of HLN and Sheriff Joe Arpaio at the Maricopa County Jail. Both are defaming Jodi Arias' character, which will cause Plaintiff Arias from receiving a fair criminal court hearing. Defendants have been broadcasting on HLN and CNN that Jodi Arias is in a sexual relationship with Christopher Alexander, who is a cousin to Travis Alexander, and reporting Plaintiffs are preparing to be married. Plaintiff Alexander was just released from the Pennsylvania Department of Corrections, and Plaintiffs were previously Pen Pals for the last five years. Sheriff Joe Arpaio intercepted sexual letters between Plaintiffs and gave them to Nancy Grace for her to report that Plaintiffs are planning to marry. This is an invasion of privacy. Nancy Grace also reported that Plaintiff Arias cheated on Travis Alexander with Plaintiff Christopher Alexander one day before Travis was murdered at a Phoenix area Super 8 Motel. Plaintiff moves to compel Nancy Grace from defaming Plaintiffs' character, which will cause Plaintiffs irreversible harm if Plaintiff's relationship is made public and cause Plaintiff Arias prejudice on her Death Penalty case.


Sheriff Joe Arpaio is also violating Plaintiff Jodi Arias' Eighth Amendment rights for Cruel and Unusual punishment. Plaintiff Arias was denied medical care on 2/14/14. Sheriff Joe Arpaio also installed video cameras illegally in Arias' cell invading her privacy and films Arias while she is using the bathroom, and sold the tapes to the media. Additionally, Sheriff Joe Arpaio has an American flag hung in Plaintiff Arias' cell and forces her to say the Pledge of Allegiance during morning count or forego meals, showers, and recreation.


